any disadvantaged rural families have limited access to the opportunities they need to become financially self sufficient. To address that, **the Rural Maryland Council** and the **Annie E. Casey Foundation** joined forces in 2005 to create the Rural Families program, which awards grants to non-profit and community-based organizations that help vulnerable families achieve economic stability. Successful applicants propose projects whose results are consistent with the Casey Foundation's Rural Family Economic Success initiative, which are:



Earn it: Families have increased income; **Keep it:** Families have more stable financial lives; **Grow it:** Families acquire assets & build wealth.

Funded projects must serve families in at least one of the rural counties: Allegany, Calvert,

Caroline, Carroll, Cecil, Charles, Dorchester, Frederick, Garrett, Harford, Kent, Queen Anne's, St. Mary's, Somerset, Talbot, Washington, Wicomico and Worchester.

Funded by the Annie E. Casey
Foundation and administered by the Rural
Maryland Council, the Rural Families
program awarded \$300,000 in grants to
14 organizations during the last three
years. In FY 2008, grant requests totaled
\$269,000 – or 269% more funds than
were available.

Rural Maryland Families: A Proven Track Record

After only two complete years (i.e., a third ends in July 2008), the Rural Families program has accomplished impressive quantitative goals. A few highlights:

- 3,080 primary grade students in high risk communities received basic personal finance lessons during 12 school assemblies. In addition, 220 educators and 3,000 parents received classroom and take-home materials to help teach personal financial responsibility to youth (Maryland Cooperative Extension, Worcester County)
- ▶ 144 Lower Shore families with incomes under \$38,000 received free tax preparation and Earned Income Tax Credit consulting. The total EITC claimed was \$87,912 for 68 federal returns, or \$1,292 per return; and \$13,509 for 34 state returns, or \$397 per return (Grantee: Lower Shore Child Care Resource Center at
- Salisbury University);

 15 families learned their credit scores and identified steps to take to repair credit ratings; 16 families learned to prepare a household budget; 13 families opened and deposited money into a savings account; and 12 families invested in an Individual Development Account (Garrett County Community Action Agency);
- ▶ 12 families affected by mental illness received training in how to navigate the service system. (Wicomico Partnership for Families & Children).
- Five families received 15 hours of home ownership training. Of them, 3 qualified for mortgages through USDA-Rural Development and 2 were mortgage ready at the end of the grant. (Maryland Rural Development Corporation)

The ultimate goal of the Rural Families program is to strengthen the financial stability of rural families. Toward that end, we intend to create a statewide network of rural family support agencies. This year, the program added a mentoring component that pairs continuing grantees with new grantees so that both can share knowledge and experiences while providing mutual support for common challenges. Two new and two returning grantees entered a mentoring relationship in 2007-08. The value of the arrangement will be evaluated this summer.
