

Results: 2006 Rural Issues Ballot

During the 2006 Maryland Rural Summit, which used the theme: "Rural Maryland Communities in Transition," we asked attendees to name the top five issues they expect their communities or organizations to confront



during the next five years. While the poll was not scientifically valid, it did provide an informed idea of what rural leaders are most concerned about and what they expect to face in the immediate future.

Making health care more accessible and affordable, and planning for residential growth that includes affordable housing but discourages sprawl, were the two biggest issues Summit participants said they expect to face in the next five years.

Protecting farmland and growing the state's agricultural and resource-based businesses was a close third.

Access to affordable health care has long been a difficulty facing rural communities; however, the problem is compounded by the fourth major issue identified on the survey: difficulty securing more quality health care practitioners and facilities.

Rounding out the top five issues identified on the poll was difficulty providing appropriate services that support new business development and entrepreneurial activity.

We thank everyone who participated in this straw poll and provided us with the ideas for planning this year's event.

Claudia R. Baquet, MD, MPH

Dr. Baquet is Associate Dean for Policy and Planning, Professor of Medicine, Epidemiology and Preventive Medicine, University of Maryland School of Medicine, and Director of Center for Health Disparities, UM School of Medicine, Baltimore. She is also the Former Deputy Assistant Secretary, HHS 1992-1994 (Minority Health); and Former Associate Director for Cancer Control Science and Chief Special Populations Research Branch National Cancer Institute 1984-1992. As Associate Dean for Policy and Planning, Dr. Baquet serves as an advocate for quality health care, including issues related to the health needs and models for underserved communities, telemedicine and rural health initiatives. She also serves as director of the Maryland Area Health Education Center Program and director of the UMB organized research center "Center for Health Policy/Health Services Research." In 2003, she became director of the University of Maryland Comprehensive Center (NIH Export P 60) for Health Disparities Research, Training and Outreach.

Christine L. Bergmark, Ph.D

Dr. Bergmark is the Executive Director of the Southern Maryland Agricultural Development Commission. In addition to creating the "So.
